## **Outline:**

Due to important developments in the energy field in the Eastern Mediterranean over the last years this increasingly fragile region is becoming the focus of an ongoing geopolitical tectonic shift affecting all countries of the region, especially Israel, Cyprus, Greece and Turkey, while Egypt as well as further Arabic countries could become further significant players in this field. These developments put the relationship between countries in the Eastern Mediterranean on a new track and will greatly affect their significance towards the realisation of EU energy policies in terms of alternative energy sources to the EU. Existing and future alliances as well as conflict potentials deriving from the energy strategies of all countries concerned in the Eastern Mediterranean region is expected to have an important impact towards either further destabilisation of this region or promotion of deeper cooperation and problem solving. However, political stability of the region and concurrent drafting of long term strategic planning along with coordination of actions between countries are the very prerequisites to this end. Against this background, the planned conference seeks to analyse which energy strategies in this fragile world region could produce geostrategic unbalances and thus additional conflict lines between states and under which conditions multilateral cooperation could support regional solutions to political conflicts and boost economic prosperity.
